6)Treasurer's Report SY- SY provided committee with a statement of accounts. Reserve and current accounts remain in credit. OVH received a calor gas bill of £1600 which has been settled. SY has arranged for the village hall energy account to be switched to British Gas Light in January, this is hoped to save over £200 a year.

7) OVH Wifi costs and contract RW & SY- OVH Wi-Fi with BT costs £45 per month, the current contract ends May 14<sup>th</sup> 2026.

Jeremy Wakeling would like to enter into a discussion with the OVH committee about the community shop taking over the contract for the Wi-Fi. The community shop would be responsible for paying the bill & the village hall would 'piggy back' from the shop.

Committee discussed a meeting to be set up with JW with BS, RW & SY to discuss options. BS to be asked to find out what the costs would be/break clauses if we ended our current contact early. Committee discussed 2 options; i-Transfer of existing name/contract to the community shop and shop to take on payment

ii-Leave the current contract with BT as it is, with shop using OVH wi-fi & paying the bill until May 14<sup>th</sup> 2025 when contract ends.

8)Community Shop Update GP – The shop would like to cosider taking on the big shed for storage instead of using the 2 smaller ones. The big shed has power & would be a more convenient space for shop use. GP & RW to look into what needs to be cleared from big shed & whether it is weather proof. The committee agreed that this was a reasonable request. GP to feedback to the shop.

9)Community Shop Solar tarrif/contract update RW- RW, SY, GP, JW & IB to arrange a meeting in August to discuss and finalise community shop payments for solar power. Proposed payment schedule to be Energy usage Total + Feed to Grid Total = Total to be split 60/40 Possible quarterly billing/payments to be discussed.
